#### 1. Overview of Operating Results, etc.

#### (1) Overview of Operating Results for the Period under Review

During the six months ended September 30, 2025, the Japanese economy faced a downward risk caused by continuous price increases and the impact of U.S. trade policies. However, the economy continued gradual recovery resulting from an improvement in employment and income conditions.

Under this situation, the Company pursued three basic policies based on the medium-term management plan, "NEXT VISION 2028": "Growth of existing partition business," "Creation of new products," and "Enhancement of production and logistics operations."

Regarding operating results for the six months ended September 30, 2025, sales of all items for office use, centered on relocatable partitions, the Company's mainstay product line, steadily grew with a backdrop of brisk demand for office relocation and renewal. In addition, sales of toilet booths for school, sports facilities, and factories grew. As a result of these factors, net sales were \(\frac{\frac{1}}{2}}21,107\) million (up 4.9% year on year). Orders received showed steady progress and were \(\frac{\frac{1}}{2}}25,185\) million (up 3.0% year on year), and order backlog totaled \(\frac{1}{2}}22,975\) million (up 9.3% year on year) and increased in all the items.

On the profitability front, the gross profit margin was 35.2% (an improvement of 1.3 percentage points year on year) mainly due to an increase in sales of high value-added products, and effects of an increase in revenue offset a rise in personnel expenses arising chiefly from an increase in base pay. As a result, operating profit was \$1,192 million (up 22.7% year on year), ordinary profit was \$1,220 million (up 16.4% year on year), and profit was \$817 million (up 10.8% year on year).

#### (2) Overview of Financial Position for the Period under Review

Regarding the financial position as of September 30, 2025, total assets decreased by \$233 million from the end of the previous fiscal year, to \$46,522 million.

In terms of assets, current assets decreased by \$3,476 million from the end of the previous fiscal year, to \$27,845 million. This is mainly due to decreases in notes and accounts receivable - trade, and contract assets of \$1,823 million, cash and deposits of \$1,605 million, and electronically recorded monetary claims - operating of \$254 million, despite an increase in inventories of \$219 million. Non-current assets increased by \$3,242 million from the end of the previous fiscal year, to \$18,676 million. This is mainly due to an increase in property, plant and equipment of \$3,202 million resulting from the recording of construction in progress due to construction work of Kaga Factory No. 2 (tentative name) of \$2,991 million.

In terms of liabilities, current liabilities decreased by \$535 million from the end of the previous fiscal year, to \$5,837 million. This is mainly due to decreases in income taxes payable of \$259 million, and accounts payable trade of \$247 million. Non-current liabilities increased by \$14 million from the end of the previous fiscal year, to \$2,606 million.

In terms of net assets, the total amount of net assets increased by \(\frac{\pmathbf{\text{2}}}{287}\) million from the end of the previous fiscal year, to \(\frac{\pmathbf{\text{3}}}{38,077}\) million. This is mainly due to an increase in retained earnings of \(\frac{\pmathbf{\text{1}}}{189}\) million resulting from the recording of profit of \(\frac{\pmathbf{\text{8}}}{817}\) million and the payment of dividends of surplus of \(\frac{\pmathbf{\text{4}}}{628}\) million. As a result, the equity ratio stood at \(81.8\)%.

Regarding cash flows for the six months ended September 30, 2025, the Company allocated funds to working capital, capital investment, and shareholder returns among other activities, while enhancing internal reserves.

As a result, cash and cash equivalents (hereinafter referred to as "cash") as of September 30, 2025 stood at \#13,029 million (\#13,373 million as of September 30, 2024). Described below are the state of each cash flow for the six months ended September 30, 2025.

#### (Cash flows from operating activities)

Net cash provided by operating activities amounted to \$2,576 million (net cash provided of \$1,677 million for the same period of the previous fiscal year). This is mainly attributable to a net increase due primarily to the recording of profit before income taxes of \$1,220 million, a decrease in trade receivables of \$2,079 million, and depreciation of \$586 million, as well as a net decrease due primarily to income taxes paid of \$638 million, a decrease in trade payables of \$247 million, and an increase in inventories of \$219 million.

#### (Cash flows from investing activities)

Net cash used in investing activities amounted to \$2,563 million (net cash used of \$1,156 million for the same period of the previous fiscal year). This is mainly attributable to a net decrease due primarily to purchase of property, plant and equipment and intangible assets of \$3,558 million, and a net increase due primarily to a net income of \$1,000 million resulting from payments into time deposits and proceeds from withdrawal of time deposits.

#### (Cash flows from financing activities)

Net cash used in financing activities amounted to \(\frac{4}632\) million (net cash used of \(\frac{4}669\) million for the same period of the previous fiscal year). This is mainly attributable to a net decrease due primarily to dividends paid of \(\frac{4}625\) million.
